### **Process feedback from Workshop 1**

- The workshop went very well but a few more people would have helped

### **Process feedback from Drop-in 1**

- The website is a bit low key – needs to be more engaging.
- The average age of participants seemed quite high.
- Those attending also seemed to be mainly more recent Totnes residents.
- Very few young people (one group booked in for a workshop failed to arrive at all).
- Quite a bit about allotments at the drop-in. *(JB explained that several members of the allotments group attended straight after a meeting held nearby.)*
- Can we clarify who the 'community garden is for? *(SM made clear that the suggested garden is [for co-housing to manage on behalf of co-housing and other site residents.](#))*

### **Content Feedback from Workshop and Drop-in**

- Including a Performance Space is good but to be successful it needs to be linked to a specific group who will use it and look after it.
- Public Art always gets a mixed reaction. It is very important and needs to be addressed sooner rather than later and key points/questions fed back to Workshop 2.
- Queries about the water taxi. *(Tides permitting, this will be from new pontoons into town, eg. the [town, possibly riverside supermarket etc.](#))*
- How are local neighbour concerns being addressed – on the design and for the construction period? *(The local group have already been involved and information is being shared. A specific discussion session is planned around the time of the second Workshop. There is currently a Draft Full Travel Plan which picks up several local concerns.)*
- Draw out the points that refer on to later phases.

### **Next Stages**

- Pick up on points above.
- Engage young people through KEVICC. JB explained his unsuccessful attempts to date. Links may be better via Tony Whitty and [Rob Hopkins](#).
- Engage young families. Access via Ian Blackwell, Dangerous Dads.
- Is there a better location for the next Drop-in – up by the market?
- More advertising/promotion out on the streets during drop-in times.
- Promote the live link for Workshop 2.
